

**HEARING

Call to Order/Pledge of Allegiance

Hearing and Discussion

President Batcheller announced that notice was provided that a hearing would be held August 7, 2006, at 12:00 p.m. local time, and that public input would be received regarding the proposed specifications, proposed form of contract and estimated cost of \$1,041,345.50 for the Sioux City Community School District's Unity Elementary School earthwork project, and that any interested party may appear and file objections and any information for or against same will be heard on the above-named project with the final decision of the Board of Education a matter of record.

Recommendation

Director Mounts moved and Director Johnson seconded the motion that the Board of Directors authorize the district to advertise for bids for the earthwork for the Sioux City Community School District's Unity Elementary School earthwork project. Superintendent Williams, as well as President Batcheller, spoke of the wonderful cooperation between the city and the district. Mr. Batcheller stated that our relationship with the city is light years from what it was in the past, and thanked Paul Eckert and Jerry Hanson, as well as Dave Ferris, for their efforts. He further stated that this cooperation is for the benefit of the community and the taxpayers. The motion carried 5-0.
