The Teacher Quality Committee (TQC) met on Tuesday, May 23, 2017, in the Educational Service Center, Professional Learning Center. Copies of the *agenda*, *February 3 minutes*, *Iowa Core Comparison Budget and TQ Detailed Budget* were available for distribution.

1. Minutes & Updates

- A. Today's Agenda review and approve agenda for today.
 - Addition to the agenda; PD Program Review. Agenda reviewed and approved with added line item.
- B. Minutes review and approve minutes from February 3 meeting. Tim moved and Sandra seconded the motion to approve the minutes as presented. Motion carried.

2. Discussion Items and Action Items

- A. ASCD Online Courses update
 - 1. 811 registered, 510 completed by May 1
 - 2. There are approximately 220 completing the course for credit
 - 3. District will only be billed for teachers who complete the course
 - 4. April will research course options for 2017-18 and solicit committee input
 - 5. Courses need to be varied to avoid duplication
 - 6. Comments are overwhelmingly positive

B. TO Budget Update

- 1. Carryover is approx. \$81,000
- 2. TQ day on August 17, 8 AM to noon (optional)
- 3. Building-based and teacher-driven PD
- 4. Approx. cost, \$150,000
- 5. The four, one-hour Mondays were attended by approx. 500 staff each session
- 6. Cost was approx. \$100,000
- 7. April will email final budget amount by July 1

Sandra moved and Tim seconded the motion to offer a half-day, optional TQ session on August 17. Motion carried. Sandra moved and Tim seconded the motion to offer the ASCD online courses again in 2017-18. Motion carried.

C. Iowa Core Update:

- 1. 594 are registered for the Iowa Core Institute
- 2. The focus will be on literacy
- 3. Teachers will be paid for the time they attend, but must be present for all 15 hours in order to earn licensure credit
- 4. The next meeting of the *Teacher Quality Committee*; August 16, 2017, ESC, ROOM 105 11:30AM-12:30 PM.

- A. Professional Development Program Review
 - 1. In general, questions about professional development's effectiveness Questions/comments from the committee members about what kinds of questions should appear on a survey;

 - Do you consider contact hours with students more or less valuable than PD on early-out Mondays?
